DO OBJETIVO

CLÁUSULA PRIMEIRA – O presente Aditivo tem por objetivo:

I – Acréscimo de 01 (um) posto de serviços de vigilância de 44 horas semanais diurnas no Edifício Sede.

DO ACRÉSCIMO

CLÁUSULA SEGUNDA - Fica ajustado entre as partes o acréscimo de 01 (um) posto de serviço de 44h instalado no Edifício Sede no valor de R\$5.470,41 (cinco mil, quatrocentos e setenta reais e quarenta e um centavos), que representa 0,648% do valor atualizado do contrato, passando o valor mensal de R\$891.946,58 (oitocentos e noventa e um mil, novecentos e quarenta e seis reais e cinquenta e oito centavos) para R\$897.416,99 (oitocentos e noventa e sete mil, quatrocentos e dezesseis reais e noventa e nove centavos), em consonância no art. 81, § 1º da lei 13.303/16 c/c artigo 105, item 1, 2, alínea “a” do Regulamento Interno de Licitações e Contratos do Banco da Amazônia.

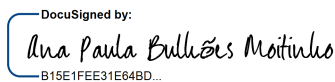
