DOS OBJETIVOS

CLÁUSULA PRIMEIRA – DO OBJETO

O presente aditivo tem por objetivo mediante comum acordo, a alteração quantitativa do Contrato nº 2024/186, no percentual de 25% do item 4 do instrumento contratual.

DA ALTERAÇÃO

CLÁUSULA SEGUNDA - Fica ajustado entre as partes, quantitativa de 25% do Lote 4, referente ao acréscimo de 125 unidades de MONITORES 23.5" POLEGADAS ao contrato original, no valor de R\$85.965,00 (oitenta e cinco mil novecentos e sessenta e cinco reais), passando o valor total do lote de R\$343.860,00 (trezentos e quarenta e três mil oitocentos e sessenta reais) para R\$429.825,00 (quatrocentos e vinte e nove mil oitocentos e vinte e cinco reais), conforme Anexo I.
