Termos de Assinatura e Registro Eletrônico

ELECTRONIC RECORD AND SIGNATURE DISCLOSURE

From time to time, HCITIS ISV OBO BASA BANCO DA AMAZONIA (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Described below are the terms and conditions for providing to you such notices and disclosures electronically through the DocuSign system. Getting paper copies

If you do not agree with this process, please let us know as described below.
